



2025 LDR ROAD RUNNING CHAMPIONSHIP BID APPLICATION

Please carefully follow these instructions to properly submit your bid for an LDR Road Championship

1. Complete Bid Application (including Championship Rights fee) Must be received no later than 5:00PM Friday November 29, 2024. Mail to USATF NJ, 150 River Road, Suite N-3, Montville, NJ 07045. Bid Application may also be emailed to ldrdivision@newjersey.usatf.org and managingdirector@newjersey.usatf.org
2. A Championship Rights fee of \$650.00 (minimum) payable to USATF-NJ must be provided at the time of the bid Application. Note: **Events may submit a Championship Rights Fee higher than \$650.00.**
3. A 2025 GRAND PRIX APPLICATION FORM shall be submitted along with the LDR CHAMPIONSHIP BID APPLICATION. The CHAMPIONSHIP RIGHTS FEE only includes the GRAND PRIX FEE for the race distance. Additional Event distances being held same day as CHAMPIONSHIP are an additional **\$30.00** per event.
4. The SANCTION FEE is to be submitted online through the National Sanction System within **30 Days** of acceptance of CHAMPIONSHIP BID or the LDR Committee reserves the right to award the Championship to another event and retain all fees. Sanction must be based on the number of participants for the events most current year results.
5. If the CHAMPIONSHIP BID is not Accepted \$250.00 will be retained for 2025 GRAND PRIX FEE and an Administration fee

- USATF-NJ Grand Prix Logos provided must be used (outdated logo use subject to \$50 penalty)
- Event must abide by current USATF Rules of Competition.
- USATF-NJ Masters (40+) Championships age group awards in 5 year age divisions.
- No double dipping USATF-NJ Overall, Masters and age group awards
- Event must provide USATF with Table race day
- Overall USATF-NJ Masters Prize Money based on current WMA age grading tables (if applicable)
- USATF-NJ Prize Money equal to or greater than non-USATF-NJ Prize Money (if applicable)

Suggested Conditions

Provide start signs with pace minutes per mile or finish time ranges. Recommended for over 300 participants

Provide Masters Awards Categories in 5 year age group divisions in Open Championships

Provide USATF-NJ Club Team Prize money in addition to USATF-NJ Individual Prize Money
